The venue of the Seventeenth AGM of the Company is strictly a Broadcast Venue as the conduct of the Seventeenth AGM of the Company will be fully virtual and live-streamed. The Broadcast Venue is also for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the meeting to be present at the main venue of the meeting. Members will not be allowed to attend the Seventeenth AGM of the Company in person at the Broadcast Venue on the day of the Meeting. Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively,"participate") remotely at the Seventeenth AGM of the Company via the Remote Participation and Voting ("RPV") facilities provided by Tricor Investor & Issuing House Services Sdn Bhd ("Tricor" or "TIIH") through its TIIH Online website at https://tiih.online. Please follow the Procedures for RPV facilities in the Administrative Details for the Seventeenth AGM. A member of the Company via the Reventeenth AGM of the Company is entitled to appoint not more than 2 proxies of his/her own choice to participate in his/her stead.
